Dear Mr. Freeland:

On November 18, 2021, the New Mexico Environment Department ("NMED") performed a multimedia inspection ("Inspection") at Freeland Inc., dba Freeland Sand & Gravel (defunct business), Freeland NM Holdings, LLC ("Freeland NM", property owner), located at 324 New Mexico State Road 512, Brazos, New Mexico 87551. Based on that Inspection and review of information obtained NMED issued a Notice of Violation ("NOV") dated January 13, 2021.

NMED has reviewed your response to the NOV dated January 25, 2022, and supporting documentation subsequently emailed. Based on that review and subsequent follow-up Inspection performed July 19, 2023, NMED has determined that the violations cited in the NOV have been adequately addressed and no further action relative to the NOV on the part of Freeland NM is required. Any action taken in response to this letter does not relieve your facility of its obligation to comply with any other applicable laws and regulations.
