| DESCRIPTION OF VIOLATION: Operating a food establishment without a vaild NMED issued Permit to Operate (see attached) |
| You are in violation of the Food Service Sanitation Act, NMSA 1978, §25-1-7 and 7.6.2 NMAC 8-301.11 (A) for selling food to the general public without a valid permit. |
| The Department may bring the following enforcement actions for operating without a permit: |
| A. Relief in district court to enjoin the operation of any food service establishment not complying with the Food Service Sanitation Act or any regulation adopted under the act, NMSA 1978, §25-1-12(A); B. Imposition of a civil penalty up to five hundred dollars (\$500) for each violation of the |
| Food Service Sanitation Act. Each and every violation of the provisions of that act shall constitute a separate offense, NMSA 1978, §25-1-12(B). |
