**NOTICE OF NON-COMPLIANCE**

This correspondence is a request for voluntary corrective action from the New Mexico Environment Department's Solid Waste Bureau ("SWB") regarding non-compliance with the New Mexico Solid Waste Act ("SWA"), NMSA 1978, Sections 74-9-1 to -42 (1990, as amended through 2011), and the New Mexico Solid Waste Rules ("SWR"), 20.9.2 – 20.9.10 NMAC, as specified below.

SWB investigation determined that approximately six or seven plastic bags containing municipal solid waste ("MSW") were placed upon the ground of your property without suitable containerization contrary to the requirements of the SWR, 20.9.2.8.B, 20.9.2.8.D and 20.9.2.10.A(1) NMAC, which prohibit the storage of non-containerized solid waste, the storage of solid waste in a manner creating a nuisance, and the storage of solid waste contrary to the requirements of the SWR, respectively.

On June 7, 2021, I visited the property at #90 County Road 328, Tierra Amarilla, New Mexico (LAT 36.72669°, LONG -106.52762°) and photographed multiple plastic bags of MSW piled upon the ground, apparently because the adjacent 55-gallon drum used for storage of your bagged trash was full. During our conversation, you stated that the bags would be removed and disposed soon, although you did not provide a timeline or deadline for proper disposal of the bagged solid waste.

The SWB hereby requests that you provide copies of the disposal tickets verifying the proper disposal of this waste at a permitted or registered solid waste facility. The failure to respond may result in additional enforcement action, which may include the assessment of a civil penalty.


