#### **RE:** Notice of Violation – Inorganics Monitoring and Reporting

Dear Gary White:

This letter serves as Notice of Violation that the New Mexico Boys and Girls Ranch water system did not complete the monitoring requirements for the inorganic contaminants listed in Table 1. The monitoring requirements for inorganic contaminants are defined in the New Mexico Drinking Water Regulations, 20.7.10.100 NMAC [incorporating 40 CFR Section 141.23, Inorganic chemical sampling and analytical requirements].

The New Mexico Environment Department Drinking Water Bureau (DWB) requires the New Mexico Boys and Girls Ranch water system to notify customers of the monitoring violations shown in Table 1 as required in 20.7.10.100 NMAC [incorporating 40 CFR Section 141.204]. <u>The notice must be provided to all customers and others who drink the water no later than one year from the date on this Notice of Violation by mail or direct delivery and the New Mexico Boys and Girls Ranch water system must repeat the notice annually for as long as the violation persists. In addition, public notice must be provided by one other method reasonably expected to reach consumers of the water system, i.e., publication in a local newspaper or posting in conspicuous locations. This notice must remain posted as long as the violation persists.</u>

Pursuant to 20.7.10.100 NMAC [incorporating 40 CFR Section 141.31(d)] the New Mexico Boys and Girls Ranch water system must certify that the notice was published and the method of publication, by submitting a completed copy of the enclosed Public Notification Certification Form to the DWB <u>within 10</u> days of completing the public notification requirements. A representative copy of each type of notice distributed, published, posted or made available to the people served by the system must be included with the certification form.

Failure to comply with the public notice requirements will result in an additional violation (failure to notify the public and the state) being issued without notice to the New Mexico Boys and Girls Ranch water system. Continued failure to comply with Public Notification Requirements, as defined in 20.7.10.100 NMAC [incorporating 40 CFR Sections 141.204 and 141.31(d)] will result in escalated

enforcement actions including issuance of Administrative Orders with possible penalties assessed against the New Mexico Boys and Girls Ranch water system.

NMED-DWB reserves the right to take additional enforcement action regarding the violations identified in this NOV, to include the issuance of an Administrative Compliance Order compelling compliance and issuing civil penalties.

#### **Template on Following Page**

If you are required to provide Tier 3 notification, you must provide public notice to persons served within one year after you learn of the violation 20.7.10.100 NMAC [incorporating 40 CFR 141.204(b)]. Multiple monitoring violations can be serious, and the NMED DWB may have more stringent requirements. Check with the NMED DWB to make sure you meet its requirements.

Community systems must use one of the following 20.7.10.100 NMAC [incorporating 40 CFR 141.204(c)]:

- Hand or direct delivery
- Mail, as a separate notice or included with the bill

Noncommunity systems must use one of the following 20.7.10.100 NMAC [incorporating 40 CFR 141.204(c)]:

- Posting in conspicuous locations
- Hand delivery
- Mail

In addition, both community and noncommunity systems must use another method reasonably calculated to reach others if they would not be reached by the first method 20.7.10.100 NMAC [incorporating 40 CFR 141.204(c)]. Such methods could include newspapers, e-mail, or delivery to community organizations. If you post the notice, it must remain posted until the violation is resolved. If the violation has already been resolved, you must post the notice for at least seven days 20.7.10.100 NMAC [incorporating 40 CFR 141.204(b)]. If you mail, post, or hand deliver, print your notice on your system's letterhead, if available.

The notice on the following page is appropriate for insertion in an annual notice or the Consumer Confidence Report (CCR), as long as public notification timing and delivery requirements are met 20.7.10.100 NMAC [incorporating 40 CFR 141.204(d)]. You may need to modify the template for a notice for individual monitoring violations. This example presents violations in a table; however, you may write out an explanation for each violation if you wish. For any monitoring violation for volatile organic compounds (VOCs) or other groups, you may list the group name in the table, but you must provide the name of every chemical in the group on the notice, e.g., in a footnote.

You may need to modify the notice if you had any monitoring violations for which monitoring later showed a maximum contaminant level or other violation. In such cases, you should refer to the public notice you issued at that time. If you do modify the notice, you must still include all required PN elements from 40 CFR 141.205(a) and leave the mandatory language unchanged (see below).

#### **Corrective Action**

#### After Issuing the Notice

# IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER Monitoring and Reporting Requirements Not Met for New Mexico Boys and Girls Ranch

On 5/23/2023 we became aware that our system recently failed to collect the correct number of drinking water samples. Although this incident was not an emergency, as our customers, you have a right to know what happened, and what we are doing to correct the situation.

\*We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. Table1 list the contaminants and the compliance periods which we did not monitor or test and therefore cannot be sure of the quality of our drinking water during the compliance periods.\*
