

# PUBLIC NOTICE Groundwater Discharge Permits Proposed for Approval December 15, 2023

#### Dear Interested Party,

The New Mexico Environment Department (NMED) Ground Water Quality Bureau (GWQB) hereby provides notice that the following Groundwater Discharge Permits have been proposed for approval. NMED will allow 30 days after the date of publication of this notice (or as otherwise provided below) for submittal of written comments and/or a request for a public hearing for a permitting action. You can add the comment period to your calendar through our Events Calendar located at <a href="https://www.env.nm.gov/events-calendar/">https://www.env.nm.gov/events-calendar/</a>. You can now submit your comments online using the Public Comment Portal located at <a href="https://nmed.commentinput.com/">https://nmed.commentinput.com/</a>. Requests for public hearing shall be in writing and shall set forth the reasons why a hearing should be held. A hearing will be held if NMED determines that there is substantial public interest. After the administrative record for a permitting action is complete and all required information is available, NMED will approve, approve with conditions, or disapprove the Permit based on the administrative record.

NMED maintains a Public Involvement Plan (PIP) for each permitting action to plan for providing public participation opportunities and information that may be needed for the community to participate in a permitting process.
